Subject: Committee Action Report for Academic Year 2011 - 2012

Date: September 28, 2012

The following **revised** report is submitted in accordance with the Faculty Senate rules.

The Admissions and Standards Committee is a Joint Committee of Faculty Senate. Its membership includes faculty, non-faculty and student representatives from several academic colleges, the Division of Student Development and Enrollment Services, Undergraduate Studies, Student Government Association and Graduate Student Association.

The committee shall consist of six faculty members, at least three of whom shall be graduate faculty, selected by the Committee on Committees (in consultation with the vice president for Student Development and Enrollment Services), one undergraduate student nominated by the president of the Student Government, one graduate student nominated by the president of the Graduate Student Association (in consultation with vice provost and dean of the College of Graduate Studies), and six members from the professional staff (selected by the vice president for Student Development and Enrollment Services).

Duties and Responsibilities:

- To consider all undergraduate student admissions that do not meet the minimum university admissions standards and that are referred to it by the Office of Undergraduate Admissions.
- 2. To consider all undergraduate student appeals of readmission decisions or academic standing.
- To consider undergraduate student appeals of decisions that have been made by the Office of Undergraduate Studies concerning late withdrawals, late drops, late adds, and medical withdrawals.

- 4. To consider continuation of undergraduate students who fail to meet CLAST requirements in accordance with appropriate rules and regulations. (Note: the CLAST requirement has been removed by the state)
- To consider graduate student appeals of decisions that have been made by the College of Graduate Studies concerning late withdrawals, late drops, late adds, and medical withdrawals.

Report of Activity:

For the academic year ending April 30, 2012 the committee heard 538 cases.

Admission Appeals – 311 (Admitted 9; 2.9%)

The committee continues its past practice of limiting approval of admission appeals to those cases where admission of the student is in the best interest of the university.

Readmission Appeals – 95 (Approved 5; 5.3%)

The approval rate for readmission appeals continues to decline. The major reason is that considerable weight is given to the readmission recommendation from the college of the major. In fact, with few exceptions, the only appeals that come to the committee are those that lack a favorable recommendation and as the data indicates, readmission without college support is extremely unlikely.

Of the five students readmitted following disqualification, all are currently enrolled and in good academic standing (UCF GPA above a 2.0).

Readmission under Academic Amnesty – 18 Cases (Approved 18; 100%)

Of the18 students readmitted under the Academic Amnesty program, 14 are currently enrolled; of those, 9 students have completed the program requirements and are currently in good standing. Of the remaining 9 students, four were just recently admitted and are do well; one student completed the program but is not currently enrolled, one student is out of the program and one student never enrolled.
