My *service* experience since coming to UCF in 2011 has included multiple leadership positions.

I believe faculty need a strong voice in shared governance, and I am willing to speak up for all Faculty with Department Chairs, with Deans, Upper Administration, and at the State level. As senate chair, my top priority is to address faculty concerns and work with the administration to find solutions that strengthen faculty success. Some of the significant issues all our faculty have faced this past year and continue to face include:

- $\Rightarrow~$  uncertainty about state and federal changes in higher education,
- $\Rightarrow$  inflationary pressure on our faculty
- $\Rightarrow$  changes to how we advise and coach our students
- $\Rightarrow$  delays in hiring and onboarding faculty, staff, and students
- $\Rightarrow$  concerns about how faculty are being evaluated
- $\Rightarrow$  changes to research space allocation

In senate this past year, these critical issues were discussed in an open manner with the president, the provost, and those administrators with the direct knowledge and understanding of the issues.

In addition to those major issues that are facing all faculty, I also want to be sure that other faculty concerns are identified and being taken care of. Over the past year the senate leadership has met individually with the senators from each of the academic units to hear about concerns and ideas that may not have been raised at committee or full senate meetings. I have also listened to individual faculty concerns and addressed those concerns through the senate and its committees.

My role as chair included guiding our discussions and debates to help the will of the majority come through, while at the same time giving each individual senator the opportunity to be heard. Over the past year, the senate:

- $\Rightarrow$  discussed critical faculty issues with 9 different university administrators
- $\Rightarrow$  had tutorials on use of Leganto and our existing interactive dashboards
- $\Rightarrow$  received updates on hiring procedures and space utilization
- $\Rightarrow$  learned how UCF responds to hurricanes and other emergencies
- $\Rightarrow~$  gave feedback on changes to advising and the GEP program
- $\Rightarrow$  passed a resolution to increase compensation for GRAs
- $\Rightarrow$  passed resolutions to update SPI questions and their usage in faculty evaluations

As the newly elected vice chair of the Advisory Council of Faculty Senates, I represent the faculty from across the Florida SUS at Board of Governors meetings and to the state legislature. I shared the impact that new laws and BOG regulations have on faculty and worked to provide solutions for unintended consequences of those laws and regulations.

I continue to foster an excellent working relationship with the Board of Trustees, where I am the visible and vocal voice in support of our faculty. I worked diligently to educate our Trustees about UCF faculty: how we teach, what tenure means, the vast array of research and scholarship areas we have, how we help serve the entire UCF community, and what resources faculty need.

I would welcome the opportunity to continue to lead our faculty through the difficult times we will face in the upcoming year.

Candidate for Chair, Faculty Senate University of Central Florida

#### **Biography & Statement of Interest**

As a higher education leader with over two decades of academic and administrative experience, I am honored to be considered for the role of Chair of the UCF Faculty Senate. Currently serving as Associate Professor in Higher Education Leadership and previously as Associate Dean of the College of Graduate Studies, my work has centered on advancing the academic mission of our university through shared governance, innovative program development, and institutional collaboration. Reflecting this reality, just a few weeks back, I taught a lesson in one of my master's classes that focused on the institutional impacts of shared governance and Higher Education Finance.

Throughout my career at UCF and in prior roles, I have championed initiatives that promote academic quality, transparency, and student success. At UCF, I have overseen large-scale projects including the implementation of the SLATE admissions system, the deployment of Kuali for graduate curriculum management, and the creation of analytics enrollment dashboards through Power BI and tableaux. This has been all with an emphasis on data-informed decision-making and inclusive planning. While serving as Associate Dean within the College of Graduate Studies, I was the administrative lead over the Graduate Curriculum Committee and the Graduate Policy Committee supporting the Faculty Senate's efforts to maintain integrity, accountability, and relevancy of the graduate student environment.

As a previous member of the Faculty Senate Executive Board (Georgia Southern University) and previously serving as an administrator supporting UCF's Graduate Council, I understand the value and responsibility of the Faculty Senate as the voice of the faculty. I believe in the power of shared governance not simply as a procedural necessity but as a principle that strengthens our academic integrity, encourages collaborative leadership, and ensures a broad spectrum of voices are meaningfully heard in shaping our future.

If elected as Chair of the Faculty Senate, my 4 goals are to:

**1. Advance Shared Governance at UCF:** As I have taught in many of my classes, shared governance remains the cornerstone of academic institutions, yet in the current climate of economic uncertainty, political pressure, and institutional restructuring, faculty roles in governance are increasingly under scrutiny or bypassed. You can consider the case at Western Virginia University in 2023 as an example of this. As such, the Chair's leadership role is to facilitate transparent and inclusive deliberations within the Senate and advocate for faculty voices in institutional decision-making, especially on strategic planning or academic priorities. To support this, research shows that institutions with robust shared

governance models foster greater trust, higher faculty morale, and more resilient academic ecosystems (Kezar & Eckel, 2004; AAUP, 2021).

2. Support Academic Excellence and Innovation: Many universities, including UCF are being challenged to redefine or expand educational relevance through interdisciplinary programs, stackable credentials, online learning, and career pathways within the perspective of upholding educational rigor. Within this context of evolving educational structures and modalities, it would be needed that the Chair of faculty senate ensure that faculty oversight of curriculum remains strong and that we have relevant Senate discussions around AI integration in teaching and research, digital transformation, and future-facing academic priorities. I have personally seen the reality of this through our own Graduate Curriculum Committee that is working hard to uphold the integrity and relevancy of our course and program offerings. As I have taught within my Higher Education Retention Strategies class that National organizations like AAC&U, CGS, APLU are calling for institutions to evolve programmatically while preserving academic standards making the Senate's role in curricular governance even more essential.

**3. Ensuring Faculty Morale and Faculty Well-Being:** Current national higher education realities have intensified concerns around faculty workload, burnout, contingent labor, and representative populations in academia. My experience and research suggest to me that the Senate Chair must lead with compassion and a commitment to faculty health and wellbeing. This can be accomplished through prioritizing issues related to faculty well-being, and ensuring inclusive decision-making and the fair allocation of resources, recognition, and support across disciplines and ranks. I am drawn to the 2023 Chronicle of Higher Education report on faculty burnout revealing that 68% of faculty felt their workload was unsustainable underscoring the need for faculty advocacy at the governance level.

**4. Enhancing Institutional Transparency:** Time and experience has helped me to understand that both Administration and Faculty are working toward the common good of the institution. We want it to be a successful and thriving place. Within these intentions, mistrust can easily arise when major institutional decisions are made without clear communication or perceived consultation. A central responsibility of the Faculty Senate Chair is to serve as both a pathway and protector of transparency. Reflecting on my HE Organizational Theory class, we discussed General Systems Theory and Cybernetics leading to the understanding that a vibrant system needs spaces to look for both consistencies and inconsistencies in practice. This leads me to believe that our Chair needs to be someone willing to build trust with administrators while holding space for critical words when dissenting positions occur.

The current higher education landscape calls for thoughtful, strategic leadership framed within collaboration and academic values. I believe my experience in graduate education, policy development, curriculum oversight, university governance, and university-wide strategy, and finally as an academic in Higher Education Leadership who has studied and

taught for over two decades on how universities operate and are led, positions me well to lead our Faculty Senate with both empathy and effectiveness.

Thank you for your consideration and the opportunity to serve our faculty community.

#### Vice Chair Candidate: Jeff Kauffman

**Biography**: Jeff Kauffman is an Associate Professor and Associate Chair in charge of undergraduate programs in the Mechanical & Aerospace Engineering Department. He conducts broad research in the areas of structural dynamics and adaptive structures, with particular emphasis on multifunctional and energyefficient structures for vibration reduction, structural morphing, and energy harvesting. His projects, funded by NSF, ONR, DoD, NASA, and industry partners, range from developing high-bandwidth, high-authority actuators for vibration testing in jet engines to taking



inspiration from how mosquitos eject drops from their wings before flight to discover new ways of decontaminating surfaces.

Jeff enjoys teaching a variety of courses, especially the Mechanical Systems Laboratory. There he gets to interact with students and enjoy their "aha!" moments in the smaller lab setting. He is fortunate to advise a fantastic research group with a great mix of graduate and undergraduate students who keep him on his toes. With Ali Gordon, he is the codirector of HYPER, an NSF REU Site that provides summer research experiences in hypersonics (73 undergraduate students since 2019). Beyond UCF, Jeff is an AIAA Associate Fellow and Chair of the Adaptive Structures Technical Committee. He frequently writes the committee's annual "Year-in-Review" article for *Aerospace America*, which lets him highlight and advertise the research his colleagues are doing.

**Candidate Statement**: I appreciate the importance of effective service. Perhaps like many of us, I started out in department/college roles and have taken on roles of greater responsibility over time. Among other committees, I served on the UPCC since 2016 (chair since 2021), was elected to the Senate in 2020, joined Steering in 2022, and was honored to serve as the Vice Chair this year. This experience has made me much more aware of how different units approach problems, and how the Senate can help find solutions. I have worked with Chair King to help advocate for faculty and to brainstorm ideas to address faculty concerns.

Perhaps the most important role of Vice Chair is to chair the Committee on Committees. This year I worked closely with each unit's representative and the Senate Office to identify faculty for the 30+ Senate committees and councils, ensuring our voice is strong. We also collaborated to fill vacancies throughout the year and provide support to the committee chairs. These committees are where a significant portion of the Senate's work actually happens, so effective advocacy there can have a tremendous impact on university policy. The role will be especially important this year with the new Committee on Committees membership. I also have represented UCF on the Advisory Council of Faculty Senates, meeting with our counterparts from other SUS institutions and advocating for our interests with the Chancellor and Board of Governors. These experiences have fostered a heightened appreciation for the role of the Senate as an institution and for the importance of shared governance in achieving the university mission.



Danny Seigler is an Associate Lecturer and Director of the Master of Research Administration program in the School of Public Administration at the University of Central Florida. With over a decade of academic experience at UCF, he has demonstrated a deep commitment to faculty governance, student success, and institutional service.

#### 4. ACADEMIC UNIT SENATOR STAFFING OF COMMITTEES

Senator staffing of Faculty Senate committees

**Each senator is required to be on one senate committee**. The recommendation is to have each senator be on a single senate committee, which allows non-senate faculty from the unit to serve on committees as well. Different units can adapt as needed based on the number of faculty they have, and the interests of their faculty. Senators will caucus together and decide which senators will fill which vacant seats, making sure that every senator is on a senate committee.

Senators from each unit will be given their own unit's Committee Status Sheet.

The top section shows committee vacancies that are highlighted yellow.

The middle section shows unit faculty that have committee terms in progress. Current senators from the unit that have terms in progress are in bold red text.

The bottom section shows those committee seats that are concluding over summer. **Current senators** from the unit that are finishing terms are **in bold text**.

-The goal today is for each unit to identify the committees that **current senators** will serve on and to share that information with the Faculty Senate Leadership.

-Done by caucusing among unit members and having discussions on what is best. -Zoom breakout rooms for each unit are set up if needed, they will not be used if all members are present in person.
