As an administrator, a committee member, a member of the faculty senate, and as an individual, I have tried to see that the faculty voice, tempered by sweet reason and framed in clear words, was heard loud and clear.

# Dr. Jeffrey W. Cornett, Instructional Programs

Cornett taught at the middle school and high school levels for ten years in Ohio and Venezuela. He received a Ph.D. from Ohio State University in 1987, and joined the faculty at UCF in 1989 after serving on the faculty at Wichita State University.

Cornett teaches a variety of courses in the College of Education including: social science instructional analysis, curriculum theory, and curriculum design. He is currently serving as the qualitative evaluator of UCF's innovative principal preparation program which is sponsored by the Danforth Foundation. In addition, he is the graduate program facilitator for Instructional Programs.

His research interests focus on teacher theorizing and decision-making about curriculum and instruction, and implications of this research for teacher education. He has conducted qualitative investigations in classrooms at the elementary, middle school, high school, and university levels. During the past year his work has appeared in the following national/international journals: Theory Into Practice, Theory and Research in Social Education, and Science Education. He is co-editor and a chapter author of Teacher personal theorizing: Connecting curriculum practice, theory and research, which is being published by SUNY Press.

Cornett has presented papers at the following national conferences during the past year: American Educational Research Association, American Educational Studies Association, American Association of School Administrators, National Council for the Social Studies, and University Council for Educational Administration. He is actively involved in the National Council for the Social Studies and serves as the chair of the exemplary research awards committee and also chair of the ad hoc committee on ethics in research. He is a member of the Board of Directors for the Florida Council for the Social Studies, a member of the publications board, and chair of the Ad Hoc Committee on Teacher Induction. His UCF service includes membership in the Teacher Education Committee at both the university and college levels, and he served as chair of the Instruction Committee for the Faculty Senate this past year.

The Faculty Senate serves a vital function in actively contributing to the governance of the University of Central Florida through its focus upon academic matters and general educational policies that impact the university community. I believe the Senate and the Administration should constantly strive to work in a collaborative spirit to enhance the reputation of UCF and the quality of education that our students receive. While collaboration does not always mean agreement among the Senators or between the Administration and the Senate, it does suggest that we all actively work together in a systematic, ethical, and democratic fashion. This effort takes collective leadership that focuses less on issues of turf and protection of the status quo, and more on clarifying vision and achieving the university's mission.
