William Self, chair, called the meeting to order at 4:01 p.m. Committee members and guests introduced themselves. The roll was circulated for signatures.

MINUTES

ANNOUNCEMENTS

The Advisory Council of Faculty Senates (ACFS) meets three times a year. This advisory body to the Florida Board of Governors represents Senate leaders from each university in the State University System. Shawn Felton with Florida International University was elected chair and Bill Self was elected vice chair for 2018-2020. As the vice chair, Bill will be attending the Florida Board of Governor meetings. The ACFS recently passed a resolution regarding performance based funding including the entire Education and General (E&G) funding in the universities budget. The resolution has been presented to Chancellor Criser.

Since the passing of Resolution 2017-2018-14 Faculty Participation on University Committees last April, Keith Koons and Rebecca Bennett have been appointed to the UCF Policy Committee and faculty nominees were just submitted for members to the University Budget and Facilities Budget Committees. In addition, the Compliance and Ethics Committee is requesting to add two faculty members to the committee.

The new Trevor Colbourn Hall has a lactation room on the 3rd floor. The administration was acknowledged and thanked for planning the room in a newly constructed building in support of Resolution 2017-2018-1 Availability of Lactation Rooms for UCF Women passed last year.

Dean Michael Johnson is the chair of the Provost search committee. The members and progress of the search can be found at <u>https://provost.ucf.edu/provost-search/</u>.

The Senate leadership team met with the deans over the summer. Issues raised have been added to the topics list.

The COACHE survey data should be received by the end of August. Faculty Excellence would like faculty nominees to look at the results and help identify priorities moving forward. Nominations are due by August 22.

President Whittaker will host the annual faculty reception on Friday, August 24, 2018 in the Pegasus Ballroom from 3:00 - 4:30 p.m. The president will also host the traditional reception on August 30 immediately following the Senate meeting.

REPORT OF THE PROVOST

Construction

The new Trevor Colbourn Hall has over 340 new offices. A celebration will be held November 14. The downtown campus planning is underway. A groundbreaker's breakfast was held Tuesday. The dean search is underway for the College of Health Professions and Sciences.

Incoming Students

This year, UCF has 316 National Merit Scholars. Incoming freshman have an average GPA of 4.08, up from 4.06 last year. The average SAT score is 1322, up from 1316 last year with an average ACT score of 28.2, up from 28.1 over last year. We should have about 7,000 transfer students this year and about 6,000 first time in college (FTIC) students. We expect about 67,000 students for the Fall semester. A member questioned if we are losing ground on the student/faculty ratio. The provost indicated that we are still committed to hiring 400 faculty. In conversation with deans, we need to make sure we are meeting the instructional need and need to add more instructors and lecturers. A member commented that more faculty are needed however, there is no space in the buildings to house the faculty and students are unable to enroll in required courses due to the class limit. The provost indicated that the deans are now receiving a report indicating classroom utilization to determine if the classroom is in use to capacity or not.

Provost Dooley announced that Dr. Jana Jasinski has been officially appointed as the vice provost for Faculty Excellence.

Performance Funding and Preeminence

If UCF doesn't achieve performance at a certain level, we risk leaving \$15 million on the table. It's not about the metrics, it's about the funds and how we can fund faculty members, programs, and that our students have access to the best student support services. We are pushing to become preeminent and be ranked in the top three for performance within the next three years. The deans are committed and the faculty are the core to student and faculty success.

NEW BUSINESS

Resolution 2018-2019-2 Guidelines for Centers and Institutes at the University of Central Florida

Resolution 2017-2018-11 approved by the Senate last year was not approved by administration with objection to the added BE IT FURTHER RESOLVED to retain any faculty that can't find a tenure home. The clause infringes on managements right to reorganize that can't be waived, creates implications for management and bargaining, and could result in a one-person unit.

Since all of the faculty in centers and institutes have been moved within academic units, the objectionable clause is no longer necessary and the resolution is being brought forward without the added clause.

Motion and second to place the resolution on the August 30 Senate agenda. The resolution is open for discussion.

Motion and second to amend line 133 by replacing the title "Exclusions" with "<u>Other</u> <u>Named Centers and Institutes</u>." Vote: All in favor; motion passes. No further discussion.

Motion and second to place the resolution on the August 30 Senate agenda. Vote: All in favor; motion passes.

<u>Resolution 2018-2019-3 Faculty Senate Bylaw Change, Committee Membership</u> This resolution is the result of a topic issue from last year. A Bylaw Revisions Ad Hoc Committee was formed in April 18 to address the issue. The resolution modifies the bylaws for every committee to elect a chair and vice chair at the first meeting. This provides a back-up for the chair in the event he/she is unable to attend a meeting.

Motion and second to place the resolution on the August 30 Senate agenda for a 30-day review prior to discussion at the September Senate meeting followed by possible amendment and vote at the October Senate meeting. A member questioned how this would work for the curriculum councils. Dr. Self indicated that a vice chair would be added to the individual curriculum committees. No discussion.

Vote: All in favor to add the resolution to the August 30 Senate agenda; motion passes.

<u>Resolution 2018-2019-4 Faculty Senate Bylaw Change, Senate Membership</u> This resolution is the result of a topic issue from last year. The Bylaw Revisions an Ad Hoc committee recommends removing the exclusive language to allow instructors or lecturers to be elected as faculty senators. The committee reviewed data from other Florida Universities, inspirational, and peer institutions that will be sent to the senators for review.

Motion and second to place the resolution on the August 30 Senate agenda for a 30-day review prior to discussion at the September Senate meeting followed by possible amendment and vote at the October Senate meeting. A member questioned if any other

faculty positions are eliminated. This relates to the faculty as defined in the Faculty Constitution Bylaws and would allow instructors, lecturers, and instructor librarians to be elected as a senator. A senator commented that it would be good information to know how many of these positions serve on committees that have not been allowed to be senators. The ACFS discussed inclusion to the Faculty Senate and determined that UCF and Florida State University are the only Florida institutions that were exclusionary. No other discussion.

Vote: All in favor to add the resolution to the August 30 Senate agenda; motion passes.

Senate Parliamentarian

Topics for 2018-2019 Senate Committee Action

Each summer, the Senate leadership meets with all deans to identify issues arising that may impact all colleges. Other topics were gathered from Steering and Senate members. Brief discussion ensued regarding issues and resolutions to administration that are bargained. Although the Senate can voice an opinion on any topic, administration can't approve a resolution involving a bargaining item. A member pointed out that there has been instances of a resolution passed regarding a bargained item to make a point that was addressed a couple of years later.

The members discussed the terminology to use for the action for each topic. Each of the following topics were assigned to a committee, postponed indefinitely or terminated. Each topic was motioned and seconded and voted all in favor unless otherwise noted.

The Institute for Simulation and Training is now a school in the College of Graduate Studies with tenured, tenure-earning and non-tenure earning faculty. In the past, the College of Graduate Studies has not had non-administrative faculty. Based on the bylaws, the new school will be apportioned in January.

In the updated UCF Parking Regulation, the regulation did not indicate that the University Parking and Transportation Committee is a Joint Committee of the Faculty Senate. After several discussions, it appears that parking and transportation is under the authority of the Board of Trustees that was delegated to the president and is questionable if the Senate has the authority or ownership to make any changes to the committee structure. We can remove the committee from the bylaws, or allow the committee to exist as is, or let the president form a new committee. Members placed the issue on the topic list.

a)	ng Definitions from BOG Reg 10.015 (repeated in UCF Reg 2.035) State of Florida Institute or Center: An entity with statewide mission, that may include two or more State universities, established to coordinate inter- institutional research, service, and teaching across the State University System. State of Florida institutes and centers must be approved by the Board of Governors. State of Florida institutes and centers' operational budgets reside within the bases of their host institutions; additional budget requests must be reviewed by the Council of Academic Vice Presidents (CAVP), and only those with a positive recommendation are carried forward to the Board of Governors for consideration. University Institute or Center: An entity that is generally established by a single university to coordinate institutional research, service, and/or educational/training activities that enhance existing instruction, research, and service at the university. The budget of a university institute or center and any requests for additional funding are wholly within the purview of the host university. Exclusions: There are entities that use the term "Institute" or "Center" in their titles, as well as some other service units, that are excluded from this policy. - 61 **Proposed Criteria and Definitional Language for Centers and Institutes**
- 62 UCF's centers and institutes are formally recognized university entities established 63 to enhance research and possibly educational and/or public service efforts to fulfill
- 64 the university's mission and goals. They generally meet the following criteria:
- 65 ✓ The unit coordinates and supports research and/or creative activities (and, 66 accordingly, fits the definition of an organized research unit), and can also 67 conduct instruction/training, public service, and/or other activities.
- 68 ✓ The unit has a distinct mission and activities that are closely tied to the 69 university's mission and goals.
- ✓ The unit conducts continuing work in a well-defined area, and work that 70 would be more difficult to undertake if the unit did not exist. 71 72
 - ✓ The university has existing strengths aligned with the unit.
- 73 ✓ The unit's budget and operations are overseen by the university, and the unit 74 is typically supported, at least in part, by recurring external funding (e.g., 75 from grants/contracts or legislative appropriations).
- 76 ✓ Faculty are not tenured in the unit unless it is also an academic unit such as a 77 college or school.
- 78

79 UCF uses the following definitions to generally distinguish between centers and 80 institutes:

- 81 *Centers* are single or multidisciplinary units organized to support research • 82 and, in some cases, other interdisciplinary activities around a specific topic 83 or issue. They are typically characterized by a narrower scope and less 84 autonomy than institutes, they are typically located within colleges/schools 85 or institutes, and they typically have recurring external funding. Some also 86 have dedicated administrative staff, commitments from faculty (FTE), and 87 evidence of long-term sustainability.
- 88 *Institutes* are generally multidisciplinary units organized to support • 89 research and, in some cases, other interdisciplinary activities around a 90 cluster of related topics or issues. Institutes are generally characterized by 91 more organizational stability, research program autonomy, and a broader 92 scope of focus than centers. They often have recurring external funding from 93 multiple sources, dedicated administrative staff, commitments from faculty 94 (FTE), and evidence of long-term sustainability.

95

96 **Types of UCF Centers and Institutes**

97 UCF acknowledges the following four types of centers and institutes, distinguished 98 in part by their levels of registration and oversight.

99

100 Type 1: State of Florida Centers and Institutes

101 These centers and institutes meet the definition and requirements listed in "a" from 102 BOG Regulation 10.015 (see above). In some instances they are established as a 103 result of legislative intent. If hosted by UCF, they must be approved by the Office of 104 Research and Commercialization (ORC), the UCF provost, the UCF president, the 105 UCF BOT, and the BOG. They must be registered with the BOG, and are overseen at 106 UCF by ORC. They must submit annual reports to the BOG and to ORC and the UCF 107 provost (or designee), and they must undergo cyclical review at least every five years.

- 108
- 109

110 Type 2: State University System (SUS) Centers and Institutes

These centers and institutes meet the definition and requirements listed in "b" from 111 112 BOG Regulation 10.015 (see above). They must be approved by ORC, the UCF

- 113 provost, and the UCF president. They must be registered with the BOG, and are
- overseen at UCF by ORC. They must submit annual reports to the BOG and to ORC 114

115 and the UCF provost (or designee), and they must undergo cyclical review at least

- 116 every seven years. These units generally have a primary research, development or
- 117 capacity building, and/or commercialization mission; some may additionally have a
- 118 service delivery mission. They are generally supported by legislative line-item 119 appropriations and/or other recurring external funding.
- 120

121 Type 3: UCF Recognized Centers and Institutes

122 These units are recognized by UCF as centers and institutes and meet UCF's criteria 123 (see above), but they do not meet the BOG definition and therefore are not 124 registered with or report to the BOG; accordingly they do not submit annual BOG reports or undergo BOG-required cyclical review. 125

126

127 They must be approved by ORC. They must submit annual reports to UCF

128 accounting for their mission and location; ORC determines with their home colleges

129 (and other units, if applicable) the appropriate lines of reporting and oversight.

130 Their range of primary missions includes research and/or creative activity, public 131 service/outreach, and dual research and public service.

132

133 **Type 4: Other Named Centers and Institutes**

134 Because they do not meet BOG and UCF definitions and criteria, UCF views these 135 units as centers or institutes in name only. Accordingly, they do not require state or

136 university-level registration or oversight. However, any unit not already using and

137 wishing to use the term "center" or "institute" in their names must seek and receive

138 approval from Academic Affairs to do so. They are overseen by and report to their

- 139 UCF home unit (e.g., college, school, and/or department).
- 140

141 Examples of excluded centers and institutes include service units that primarily 142 provide services to the UCF community, research support units for UCF faculty, 143 units that provide student awards and exchanges, public service units without a 144 significant research element, auxiliary units, and buildings or facilities. Existing excluded centers and institutes, and units wishing to use the term "center" or 145 146 "institute" in their names are strongly encouraged to consider whether the unit 147 meet's UCF's definitions and criteria (see above) and whether one of the following 148 designations would be more suitable: 149 • **Research groups, collaboratives or alliances** are generally groups of 150 investigators aligned around a shared topic or set of topics, but are less 151 formally and tightly connected than clusters.

- Initiatives are generally units organized to complete limited-term projects or efforts with specific foci and objectives. They typically do not have separate administrative structures but can involve members of multiple units and distinct resources, budgets, and lines of funding. *(e.g., UCF Literacy Initiative)*
- Offices are generally permanent units organized to oversee and administer a
 specific set of ongoing duties and/or services. They can range from
 university-level administrative or support units to units that support colleges
 or departments.
 - **Consortia** are generally partnerships among institutions (higher ed, public, private) that cooperate and/or combine resources around a shared problem or issue. *(e.g., Florida Consortium of Metropolitan Research Universities)*
 - Programs
 - Laboratories
