7. Office of Research External Review – *Elizabeth Klonoff*
 - a) An external review panel is conducting a review on the Office of Research
 - b) The external panel includes people from Arizona State, Ohio State University? And others?
 - c) Main questions that are being asked and reviewed are: (1) Where commercialization should be placed; (2) How to incentivize faculty research; (3) How to recruit and retain the best faculty (we lost quite number of successful faculty after substantial startup and other support were provided to the faculty); (4) Where should be our research focus moving forward? For example, supporting those who can bring big dollars? Move further towards interdisciplinary research?

8. Other Business

- a) Debopam – (1) There were some incentives for research active faculty, for example, out of cycle salary raise, however, this incentive appears to have gone away; (2) we are good at recruiting, but not good at retention; (3) aging infrastructure is a problem
- b) Carmen Giugeau – from nursing; lack of support such as statistician is a big problem for them
- c) Debopam – trusted chair position, it seems this program is being terminated? Some clarify that trusted chairs are 5-year position and subject to competitive renewal
- d) Liz – COI is the most important/urgent issue that ORC needs to deal with at this moment. She encourages faculty participation.
