 - Vaping Issues and Effects on Health and safety Kris Singh:
 Tom mentioned that someone raised the issue and there could be some concern. There was a flyer from Texas A&M about the same issue. Gary stated that vaping is simply treated in the same manner like smoking in campus; banned!. The issue has not been addressed at the university level and has not been a concern (Carl) University policies for smoking is applied for vaping.
 - 2. Back-In Parking:
