- 5. Announcements *Joseph Harrington*
 - a) No announcements
- 6. Report of the Senate Chair *Joseph Harrington*
 - a) The National Science Foundation has announced that the Arecibo radio telescope will be decommissioned because a second cable broke this fall. In inspecting the damage, it was discovered that two other cables were also failing, therefore, the telescope will be decommissioned safely so as not to damage any other buildings.
 - b) Cognito Training The Board of Governors has made this training mandatory. Chair Harrington asked everyone to do the training and to go back to their



- departments and notify the rest of the employees that it is mandatory. He stated that he took the training and thought it was excellent and very well done.
- c) Revised Conflict of Interest The Research Council is currently working with the Compliance Office on the revision of the Conflict of Interest policy. He said that an email that came out asking whether public commenters would like their emails redacted in the comments caused concern about the possibility of their comments being made public. He reminded everyone that because we are a public university, the comments are public and subject to records requests. He apologized to those who were surprised by the request and stated that, in response to the concerns, no comments would be posted publicly by the Senate, nor have any been.

7. Report of the President – Alexander Cartwright

- a) The President announced that a new Senior Vice President for Administration and Finance has been selected. Gerald Hector is expected to start after the first of the year. He also said that several searches are coming up for Student Development and Enrollment Services, as well as Diversity, Equity and Inclusion. He mentioned that General Counsel Scott Cole is leaving and thanked him for everything he has done for the university. A national search for a new General Counsel will be held and Associate Vice President and Senior Deputy Counsel Youndy Cook will serve as Interim General Counsel.
- b) The President has been holding meeting with units around the university to discuss their vision for the future and to get their input. He will be holding a virtual end-of-semester open forum on December 4th to give additional updates on critical topics, as well as to describe what was learned in the listening sessions.
- c) Looking forward to the spring semester, the President thanked the faculty for continuing to engage with him and the Provost on how to do the best we can during this difficult time. He appreciated having such questions and input. Everyone has been trying to do their best for the university and he hoped that the upcoming breaks will give everyone time to rest and recharge. He is hopeful that the vaccine is effective and looks forward to face-to-face Faculty Senate meetings in the future.
- d) A senator wanted to know what the university and individual professors can do with learning and helping with the level of dissatisfaction with the current remote teaching situation. The president said that faculty can ask the students how they felt about their class. Students are asking for flexibility and making sure we use the best online tools. He asked for help in coming up with best practices. The Provost said that Jana Jasinski, Vice Provost for Faculty Excellence, has been working on this through the Keep Teaching website. He recommends sending ideas to her, as well as any issues that come up. The President would like to see this information collated and shared on the website.
- e) Another senator wanted to know if the search for the Dean of University Libraries is going forward. The Provost said yes, and they are in the process of picking a search firm.
- f) A senator asked about the push back at the beginning of fall about Zoom. She stated that later in the semester the students expressed that they were very pleased with Zoom. The President said that he agrees and would need to find



- ways to assess the outcomes. He would like to use the best we've learned from the pandemic going forward. The Provost stated that there are many students who are not happy with this type of curriculum delivery. He noted that Zoom can be more social than other types of online media.
- g) Another senator said that he felt that faculty should be giving students a more realistic perspective that this is a difficult time and that things may not get back to the way they were. The President said that the survey of the students showed that students are generally understanding of this.
- h) A senator talked about the push in the past for more online classes and is now concerned because it appears that the students are dissatisfied with online learning. The Provost clarified that in the past it was a process in which faculty put a lot of work into creating these classes. He stated that the students were talking about classes that were suddenly moved to remote, synchronous Zoom classes. She suggested that there be a discussion about how many classes should be online. The President confirmed that a conversation needs to occur about which classes should be online and which ones should be in person. He noted that there are many students who are satisfied with online classes.
- i) Another senator mentioned that there is a fine line between compassion for students and students taking advantage of a situation.
- j) A senator asked about the capabilities of Web Courses. He noted that faculty in his college are having problems with assessments in Web Courses. The Provost said he understood this problem and agreed that there need to be better tools for assessments in Web Courses.
- k) Chair Harrington asked for a summary of the financial condition of the university. The President said he is still waiting to hear from the state and that it may be spring before we find out, but in the meantime, the university has acted on what is known. He feels that a vaccine will help with concerns around athletics. It is not known what cuts will be coming in the spring but he expects the strategic investment fund will help. The increase in enrollment will also help. The Provost said that it is a challenge to be in the middle of the fiscal year and be unclear about the financial future. He said the President was forward thinking in taking precautions.

8. Report of the Provost – *Michael Johnson*

- a) During this time of giving thanks, the Provost said he is thankful for the hard work of the faculty for continuing to teach well in very hard times.
- b) On the whole, teaching has been effective this fall, and faculty have been very flexible. He acknowledged that surveys of students showed unhappiness with their learning this fall. The campus experience is important for student success and it is our obligation to do the best we can to provide this experience. He had asked the deans to provide more face-to-face classes. Many will continue to be remote due to COVID capacity limitations.
- c) The exemption form has been updated to include pregnancy, as well as being 70 or older. The deadline has been extended to tomorrow (November 20). Of the 248 requests received, 207 have been granted, 35 have been denied and 6 are pending review.
- d) The Faculty Senate survey showed the majority of faculty concerned about or opposed to returning to face-to-face. He noted that there was much caution

taken when returning in fall and cases were spiking. Overall, the campus community has done well complying with COVID precautions. There has been no transmission in classrooms. Given the constraints of teaching exemptions and classroom capacity, there will be 3100 sections this spring that have an oncampus component. This is above 2100 in fall, but below 5600 last spring. Cases are up slightly, but mostly stable. Classes will go remote after Thanksgiving, but all services on campus will be open.

- e) It is now probable that a vaccine will become available in the coming months. UCF is one of the locations that will distribute the vaccine.
- f) Fall enrollment numbers Just under 72,000 head count, that's an increase of 3.5%. Our minority enrollment has reached a new high of 48.5% and he feels we will be majority minority in a couple of years. He addressed the issue of why enrollment grew when it was not supposed to and said that it had to do with the decision to admit more first time in college (FTIC) students because it looked like enrollment numbers nationally were going to be down. Next fall is still unpredictable, since FTIC applications are down by about ¼ of where they were last year. Transfer applications are down 18% and the number of test scores that have been received are down by about 1/3. Florida is one of two states that is requiring these tests in the COVID 19 environment. Dr. Berry and her group have worked out a way for students who plan to attend UCF to take the ACT at the testing center at UCF.
- g) International Education Week (IEW) is going on this week. It is important for the campus to have a good population of international students. The numbers are down at UCF and everywhere. This is an area that needs to be focused on in the coming years. There is a committee formed to study this.
- h) A senator wanted to know if there will be a period where faculty can apply for exemptions at the beginning of each semester, as situations may change for those individuals. The Provost said there was a deadline for spring so that students can know what they are registering for. He does not know whether there will be a future request for exemptions, depending on what happens with the vaccine. He said that if we are in a similar situation, they will extend the exemption form again.
- i) Another senator wanted to know if there are plans for closing the university, as we did last spring. The Provost said that there are plans for going to remote teaching if the situation worsens.
- j) A senator asked about teachers wearing masks in the classroom. He wanted to know if masks would be required once the vaccine is released. The Provost said that he has not spoken with Dr. Deichen about that yet but will need to discuss it.
- k) Chair Harrington noted that one of the senate meetings is during spring break. The senate leadership will reschedule the Spring meetings to prevent this.

9. Committee Reports

- a) Ad Hoc Budget and Labor Crisis Response Kelly Semrad, Vice Chair
 - i) The committee did not meet since last meeting but will meet after Thanksgiving.
- b) Ad Hoc Health and Safety Crisis Response Stephen King, Chair



- i) The committee has met multiple times since last meeting. Senator King reviewed the qualitative data from the faculty survey (see meeting materials) and noted that these were open ended questions. Of the 1000 people who answered the survey, 300-400 people answered the open-ended questions. The vast majority expressed concerns about teaching in the spring. They also expressed concerns about technology issues and said they felt they were not receiving the help they needed. The committee reviewed and discussed the answers.
- ii) The committee also discussed students returning in spring and how they will be tested. There were 160 cases identified at the beginning of the fall semester and now there are 120-130 cases a week. They would like to see students being tested as they come back in the spring like they were in the fall.
- iii) Surveillance testing on campus was done at Greek housing and other groups and some non-Greek dorms. The committee would like to hear more about these results.
- iv) If the university must pivot, the committee feels the faculty would like more warning than they had last spring.
- v) The Provost said there are plans underway for using rapid testing for returning students. Maribeth Ehasz, Vice President of Student Development and Enrollment Services, said that there is a meeting scheduled on Monday to finalize the plans. They are looking at different companies to operate the testing, like they did in the fall term. The President said there would be an update provided on testing.
- vi) A senator pointed out the issue about preparing for brief periods of online teaching if a faculty member or students test positive for COVID-19.
- vii) Another senator mentioned that even though classes are going online, campus services are staying open and wanted to know if there were any trigger numbers that would close campus. The Provost said that it depends more on what is happening with the hospitals and medical services availability and consultation with local public health officials.
- viii)Chair Harrington stated that his concern with the spring is students who have risk conditions and cannot take face-to-face classes and must take the class online and wanted to know if there will be services available to help the faculty.

10. Old Business

- a) COVID-19 on Campus
 - i) Ayan Desai from the Student Government Association presented the followup student survey data. (See meeting materials)
 - ii) A senator pointed out that this survey doesn't support that students are unhappy with their learning experience. The Provost stated that the students are less pleased with their learning experience this fall than he had hoped for.
 - iii) Mr. Desai stated that the survey shows that the synchronous online classes are the ones that the students are not enjoying.
- b) Discussion of Time Change to Start at 3:00 for Senate and Steering Committee Meetings beginning in 2021-2022 Senate Year



i) Poll taken, 35 yes/16 no, leadership will take this into consideration and determine whether to make the time change starting in the fall of 2021.

- b) Senator King gave an overview of the resolution. It is noted that these positions do affect the staff, faculty and students and faculty would like to participate in reviews of these positions. The Personnel Committee would like to see something similar to a dean review for vice presidents and vice provosts.
- c) Motion to approve the resolution, second
- d) A senator thanked the committee and supports the resolution. He noted that the president considers similar reviews for vice presidents and vice provosts that are not faculty-facing as well.
- e) Vote taken; motion passed with 46 yes/0 no

 - i) Policy committee approved the recommendation to request that the standardized tests required for the Ph.D. program, such as GRE and GMAT, which is currently part of a university regulation be removed from being a university regulation to being part of the regular graduate policy and this will require a recommendation from Provost and President.
- g) Undergraduate Council William Self
 - i) There are two items for UPCC to vote on next month. The first one is "ban the box", where they will ask administration to remove some of the questions that are asked of students applying to UCF about past felony convictions. The second one is the late withdrawal grading policy brought by Tim Letzring, Senior Associate Provost for Academic Affairs. This would be a change in the way the Registrar's office deals with late withdrawals.
- h) Ad Hoc Campus Equity, Inclusion and Diversity Joseph Harrington
 - i) The leadership is still forming this committee.
- i) Ad Hoc Internal Communications Joseph Harrington
 - i) The committee has not met.
- 13. Motion to move Campus Climate Report to current point in meeting, second, vote taken, passed 48 yes/1 no
- 14. Campus Climate Reports



- a) University Libraries (attachment) Frank Allen, Interim Director; Penny Beile, Associate Director, Research, Education and Engagement and Ying Zhang, Interim Associate Director, Collection Services & Resource Management
 - i) Photos shown of the new addition to the library. Opened last August and features 482 seats. Furniture has been moved for social distancing. Entire 4th floor is quiet study zone. Most seating has USB and power outlets. This is the first leg of the reconstruction. The older section will then be remodeled.
 - ii) Ying Zhang Library materials budget She noted that much of the funds are going to online journals supporting the programs and curriculum. She reviewed the current subscriptions. She noted that some packages will be going away if they receive a budget cut.
 - iii) Penny Beile Transition to remote services Students and faculty were able to access all services online when campus was shut down. Return to campus at the beginning of the fall semester, they reopened within pandemic occupancy guidelines. She would like to see course materials adopted that are free to students. Using online textbooks instead of hard copy textbooks.
- 15. Motion to extend time of meeting by 15 minutes, second, vote taken, motion passed 27 yes/13 no
 - i) A senator wanted to know if this information included the bookstore eBooks.
 Ms. Beile said that these eBooks do not go through the bookstore. Ms.
 Zhang said that these books are unlimited downloads.
 - ii) Another senator asked about the library budget and noted that there was a Resolution by the Faculty Senate in 1992-1993 regarding the library budget and it being a priority as far as being immune from budget cuts (http://facultysenate.ucf.edu/resolutions/1992_1993/index.asp#res5). She posted the resolution in the chat for everyone to review. She is advocating for the library and stated that an amendment to the resolution will be coming forward. Ms. Zhang said it is not a library problem, but a university problem, when faculty cannot get the resources that they need because the library cannot afford to purchase them.
 - iii) Chair Harrington noted that the Provost protected the library from the first 3% cut levied by the President this year.
 - iv) A senator stated that the resources that are cheaper for students are important. He would like the library to help faculty to find these resources, as well as companion testing products. Ms. Beile said that they are open to speaking with faculty about these items.
 - v) Chair Harrington encouraged everyone to write open access textbooks. Interim Director Allen said the budget numbers reflected the full, planned 8% cut, which was a worst-case scenario. He appreciated the protection from the 3% actual cut.
 - b) Motion made to extend meeting by 10 minutes to hear report, second, vote taken, motion passed 25 yes/11 no
 - c) UFF Update Nina Orlovskaya
 - i) Article 23 for Salaries review of collective bargaining session presentation (attached).



16. Other Business

a) There will be a schedule change for spring Steering Committee and Faculty Senate meetings due to Spring Break being moved. March and April meetings would be moved earlier by one week.



What is your Class Standing?







Which UCF Campus(es) do you attend and take classes? (select all that apply)





What was your living situation before the start of the COVID-19 pandemic?







Are you an international student? (meaning you are a student studying on a visa)













Has your academic performance been better or worse compared to before COVID-19?







What type of classes are you currently taking?






How satisfied are you with the way Blend Flex Classes were introduced and prepared?


How satisfied are you with the way In-Person Classes were introduced and prepared?


How satisfied are you with the way Online Synchronous Classes were introduced and prepared?


How satisfied are you with the way Online Asynchronous Classes were introduced and prepared?


How satisfied are you with the size for in-person and blend flex classes?




What proctoring method would you prefer? (Only Choose 1)






How likely would you attend a class if a student/ professor would not wear their mask (in-person classes)?


How likely would you confront and address a student or faculty member not wearing their mask?


How likely would you attend class if more in person events were to be allowed on campus?


How likely would you attend an UCF Athletics game this or next semester?


How well has the UCF RWC done during the COVID-19 pandemic?








If there was an unexpected increase of cases of COVID-19, what would you want UCF to do?















- Based on the data, most students want to have in person class opportunities, but they do not want to be forced into one choice so having an online sections
- The data shows and supports student wanting mask required for in person classes
- The data also recommends that UCF regularly clean classrooms
- The data shows that student want access to their recreation faculties, but are open to social distancing rules enforced and constant cleaning of high-volume areas and equipment
- Students want to be on campus, and they want to be in class, but they want to know that steps are being taken to keep them safe



- Based on the data student will need help with financials when it comes to paying for rent and UCF should advocate for its students and speak with nonaffiliated and affiliated UCF housing options to discuss brining down rent
- It maybe helpful to talk with all housing option for UCF students to potentially give students the option to break their lease for this upcoming year.
- The data shows many students are going to be facing mental health challenges and UCF would be advised to bring and train more professors and professional staff to be able to talk with students about stress or struggles
- These are not new challenges, but they will be exacerbated by COVID-19



- In the case of an unexpected outbreak in cases of COVID-19, students would recommend that we close UCF entirely, where we could potentially close campus, but keep things like housing open for certain cases for our students
- Students recognize that UCF may have to adjust their plans as the year goes on
- We need to be able to teach more students that its ok to confront others about not wearing mask
- There needs to be better enforcing of social distancing protocols throughout
- UCF should continue to follow guidelines from the CDC



- Students are ok with there being more in-person events so if students are following social distancing guidelines
- More off campus safety needs to be promoted especially with the increase in cases that we have been seeing



 These recommendations are based on the data that we gained from students, but we recognize that students re not the only voice, Faculty, staff, and other campus stakeholders should all make sure their voices are being heard as well.

Resolution 2020-2021-6 Five-Year Review of Faculty-Facing Vice Presidents and Vice Provosts

Whereas, The University of Central Florida is committed to an open and transparent evaluation process for all faculty, staff, and administrators; and

Whereas, many faculty-facing vice presidents and vice provosts have not had an evaluation that included broad and meaningful input from all the stakeholders that the vice presidents and vice provosts interact with and over which they have supervision; and

Whereas, the current evaluation process does not provide adequate input from faculty and other relevant stakeholders into the initial or recurrent evaluation of many faculty-facing vice presidents and vice provosts; and

Whereas, UCF has a well-developed evaluation process for deans at five-year intervals, which includes specific steps such as the charging of an evaluation review committee led by a peer, the filling of the committee with designated categories of faculty, staff, student, and administrative members, campus communication of the evaluation, feedback of the dean's performance provided by a survey, committee review of the feedback, and delivery of a report to the provost; therefore

Be It Resolved that the offices of the president and provost develop a procedure for five-year evaluation of all faculty-facing vice presidents and vice provosts that mirrors the review committee process developed for deans; and

Be it Further Resolved that faculty and all relevant stakeholders have the ability to provide feedback concerning the strengths and weaknesses of the vice presidents or vice provosts to this review committee; and

Be it Further Resolved that the president or provost shall use the committee report as advisory in nature to make a decision to renew or discontinue appointment of the vice president or vice provost under review.

Faculty Senate Budget and Administrative Committee Update

Nov. 18: The Committee had a discussion about the UCF Policy (4-506) requiring on-campus conferences to be organized in coordination with Continuing Education. It appears that the policy isn't being applied uniformly across various colleges. Following the discussion, committee members were mixed regarding whether the committee was the appropriate venue for this topic. A motion to table the discussion failed to pass by one vote. The meeting ended with a determination of how best to proceed,

Oct. 28: The Committee continued its discussion regarding the library budget from the previous meeting regarding. The committee remains concerned about the underfunding of the library. Two members volunteered to bring a draft resolution to the committee for our December meeting. We also received an update on the ERP process with Michael Sink, VP for Information Technology and Chief Information Officer.

Faculty Senate Parking, Transportation & Safety Report

New business:

Two main points of discussion/concern

 Faculty reports of being stopped and asked to show proof of completing COVID self-check on phone. I contacted Rhonda Bishop (VP of risk and compliance and chair of emerging issues and crisis response team (EICRT)) for clarification. In her response Rhonda provided the following information.

The development of the Armor Up Ambassadors was initiated and approved through EICRT. The group is overseen by Wellness and Health Promotion within student development and enrollment services (SDES). Their purpose is to reinforce our health measures on campus through friendly reminders, including checking for completion of the COVID Self Checker that is required of students, faculty, staff, and visitors when on campus. The Ambassadors have also concentrated efforts at the Student Union, Library, Residence Halls, and near classroom buildings to assist in improving compliance. The Armor Up Ambassadors are doing friendly reminders, however, they will not force a faculty member to show them they are cleared.

Rhonda kindly referenced numerous UCF publications referencing the program. Nevertheless, a number of faculty/staff do not appear to be well-informed of this activity.

2. Faculty reports of issues relating to student COVID-19 status (positive vs negative).

We had a faculty report of students showing up to class during their two-week isolation period after testing positive for COVID. The faculty member had received emails concerning two students from Jana Jasinski's office that said students had tested positive for COVID. Faculty did not receive further update on the students status. One of the students provided the faculty member with documentation of testing negative for COVID following class, but the student is still showing as positive according to UCF records and has not been officially cleared to return to campus. There was concern among committee members that the UCF reports/records of student COVID status may not be either correct or up to date or that the records are not being updated in a timely fashion.

Other Business

Personnel update:

Discussed resolution about administrator review with good discussion of whether this resolution should be just for faculty facing, or all vice presidents and vice provosts. The committee expects the review process to coordinate with faculty senate to identify which administrators are faculty facing, as job titles may switch or be changed over time and its people with certain duties and interactions that are important to evaluate this way. Ultimately the committee approved a resolution that used "faculty facing" as those vice presidents and vice provosts were the most critical ones for faculty to have input with.

Discussed the spousal conflict of interest topic: There is now a specific form from graduate studies that can be used if spouses are on the same thesis committee. The form makes it clear what is expected if that situation occurs. The spousal conflict of interest policies are not uniformly across the campus, with research having the most restrictive policy. That appears to be for historical reasons, and not a purposeful campus strategy.










Library Materials Budget & Allocation in the Past 5 Years






