## November 16<sup>th</sup> steering committee chair report

I'll provide updates from the Board of Governors meeting that occurred last week and the Board of Trustees meeting that occurred earlier today.

As I mentioned at the full senate meeting 2 weeks ago, the Board of Governors considered the proposed Regulation 9.016 Prohibited Expenditures.

The single faculty member and the single student member of the BOG each spoke against the regulation and there were multiple members of the public that spoke against the regulation in the public comment period. However, the regulation was ultimately passed with the same wording I reported on at Senate 2 weeks ago. Honestly, this was the expected outcome.

There was a surprise move during the BOG meeting on Regulation 8.005 General Education Core Course Options. But to talk about that surprise, I need to start with some background.

The Board of Governors oversaw the process of reviewing General Education Core Course Options by utilizing Committees with faculty members from the SUS institutions that were subject area experts. The committees generally proposed keeping things the same, with the addition of both *Introduction to Geology* and *Introduction to Oceanography* to the list of Natural Science classes.

The surprise came when during the committee stage, a Governor proposed to change the courses in the Social Sciences by **removing** *Principles of Sociology* and replacing it with *Introductory Survey to 1877*. This change was approved **over the objections** of the faculty and student members, and is in the process of being approved as a General Education Core Course Options. This is clearly not well thought out. In the Social Sciences section of courses, how can you remove the only dedicated sociology course as a General Education Core Course Options?

When I sent the email to all faculty mentioning the prohibited Expenditures Regulation, I wish I had included discussion of the change to Regulation 8.005 General Education Core Course Options as well. I encourage faculty to individually comment on both Regulations within the next week on the Comment website that is listed in the email that went out on Tuesday.

Overall, the BOG meeting was quite depressing, with only a few sprinkled notes of positive actions or changes.

**Now to the Board of Trustees meeting that occurred today**. In stark contrast to the BOG meeting, the BOT meeting was full of energy and meaningful discussion about planning where UCF needs to go in the future.

There was open discussion of both the positives and negatives, with a candid appreciation of the headwinds we are facing.

Some notable topics brought to the board included:

Two new MS degree programs-

an MS in Health Sciences

and an MS in Robotics and Autonomous Systems.

The BOT also discussed:

A new Academic Advising plan to improve student success, (we will address this later in the agenda)

A University Planning Structure to focus strategic resources in alignment with the UCF Strategic plan,

and

A Space Utilization Study that focused on Research Space needs now and into the future

For all three of these topics there was useful and critical discussion As the **sole Faculty member on the BOT**, I will continue to do my best to provide **meaningful faculty input** into the ways UCF is moving toward its Strategic Goals.

## **UCF Faculty Senate Steering Committee Update**

- Thank you, Steve.
- The provost is attending the Board of Trustees meeting today, but I'm happy to provide some brief updates today on his behalf.
- As Steve has mentioned, we've been waiting for greater clarity from the state regarding DEI and prohibited expenditures, and an approval process must still run its course before we know exactly what is to come. The BOG's related reg posted for public comment through next Thursday could change some by when the board approves it, which will likely be in late January. We will share more as we know more. BOG regulation 8.005 is also available for comment. This is the regulation that discusses general education requirements.
- There were two provost emails this week to the campus community.
- Yesterday was Chief Information Officer Matt Hall's last day at UCF. The provost named Dean Sheila Amin of the Burnett Honors College to temporarily lead UCF IT while continuing in her dean role. Dean Sheila's is a collaborative leader who will help keep the workflow and UCF IT progressing as we review our IT and operations in looking toward permanent leadership. The provost said he expects a short search.
- Also, following up on his Senate report from last month, the provost outlined UCF's new undergraduate advising model geared to advancing student success and our efforts to reach preeminence. If you haven't read his email, I refer you to it for more on how advising and coaching at UCF are intended to work for the better in the future.
- This morning the President sent an email that UCF will be closed on the Wednesday before Thanksgiving.
- The Office of Research and the Workday team will be updating the PI-dashboard the week after Thanksgiving. There will be training sessions for faculty the week of November 27<sup>th</sup> and December 4<sup>th</sup>. Trainings will be recorded and published. Features to note: overhead, startup, prize, and gift account reports can be exported in Excel or as a pdf of the dashboard data. Nearly all the functionality of Paris is in this tool. The updates will be demoed at the next Research Council meeting. You can also reach out to Joe Harrington.
- This is a time for looking forward to the holiday season, but it can also be stressful for students and our colleagues. Let us remember that UCF provides significant student care-related programs and resources through UCF Cares, and the Employee Assistance Program is a wonderful confidential and free resource for faculty and staff who may be struggling with any number of personal issues. Also, Therapy Assistance Online is a practical free resource offered to students, faculty, *and* staff through Counseling and Psychological Services.

• In closing, thanks for all you do to enhance our university, and have a safe and relaxing Thanksgiving.

## Resolution 2023-2024-5 Board of Governors *Regulation 9.016 Prohibited Expenditures*

Whereas, the First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances"; and

Whereas, the Board of Governors Regulation 9.016 Prohibited Expenditures, may prohibit universities, student-led organizations, and people working within and/or attending the State University System from exercising their duty to educate and train students and/or to support student led organizations that may engage in advocacy to effect "change to a government policy, action, or function"; and

**Whereas**, Appendix A State University System of Florida **Statement of Free Expression** was approved by the Board of Governors on April 15, 2019, and states, in part:

"A fundamental purpose of an institution of higher education is to provide a learning environment where divergent ideas, opinions, and philosophies, new and old, can be rigorously debated and critically evaluated. Through this process, often referred to as the marketplace of ideas, individuals are free to express any ideas and opinions they wish, even if others may disagree with them or find those ideas and opinions to be offensive or otherwise antithetical to their own worldview. The very process of debating divergent ideas and challenging others' opinions develops the intellectual skills necessary to respectfully argue through civil discourse. Development of such skills leads to personal and scholarly growth and is an essential component of each of our institutions' academic and research missions.

It is equally important not to stifle the dissemination of any ideas, even if other members of our community may find those ideas abhorrent. Individuals wishing to express ideas with which others may disagree must be free to do so without fear of being bullied, threatened, or silenced. This does not mean that such ideas should go unchallenged, as that is part of the learning process. And though we believe all members of our campus communities have a role to play in promoting civility and mutual respect in that type of discourse, we must not let concerns over civility or respect be used as a reason to silence expression. We should empower and enable one another to speak and listen, rather than interfere with or silence the open expression of ideas"; and

Whereas, the Board of Governors *Regulation 9.016 Prohibited Expenditures* will stifle the discussion and consideration of speech required as described in the Board of Governor's **Statement of Free Expression** relating to *"race, color, sex, national origin, gender identity, or sexual orientation"*, speech *"with a purpose of effecting or preventing change to a government policy, action, or function, or any activity intended to achieve a* 

desired result related to social issues", and speech on "topics that polarize or divide society among political, ideological, moral or religious beliefs"; and

Whereas the Board of Governors *Regulation 9.016 Prohibited Expenditures* is imprecisely worded and ambiguous about what activities are likely to be interpreted as attempts "to equalize or increase outcomes, participation or representation" or student activities or organizations, or university programs, that aim to "achieve a desired result related to social issues", which may inadvertently intimidate or discourage activities that are protected by academic freedom or by the **First Amendment of the United States Constitution**; therefore

**Be It Resolved**, that University of Central Florida Faculty Senate urges the Board of Governors to revise *Regulation 9.016 Prohibited Expenditures* so that the definitions within the Regulation, when combined with the expenditure prohibitions of the Regulation, no longer conflict with the **First Amendment of the United States Constitution**, or the Board of Governors' own **Statement of Free Expression**; and

**Be It Further Resolved**, that University of Central Florida Faculty Senate urges the Board of Governors to revise *Regulation 9.016 Prohibited Expenditures* so that the State University System institutions can freely support their Board of Governorapproved and Board of Trustee-approved Missions and Strategic Plans, which focus in large part on supporting the success of the more than 430,000 diverse students across the State University System.
