Minutes for meeting of Thursday, October 21, 2021, 3:00 pm

- 1) Quorum reached and call to order at 3:03 p.m.
- 2) Roll Call via Qualtrics Faculty Senate Chair Joseph Harrington, Vice Chair Stephen King, Secretary Kristine Shrauger and Past Chair William Self were present. (see meeting materials Attachment A for list of participants)
- 3) Approval of Minutes of September 23, 2021
 - a) Chair Harrington asked whether there were any amendments to the minutes. There were no amendments, minutes were approved as presented.
- 4) Announcements Joseph Harrington
 - a) Chair Harrington turned the floor over to Senator King to report on the strategic planning working group which has been meeting every two weeks. He said that faculty forums are meeting on Tuesdays and Wednesdays, with a different topic each week. The next topic is scholarship and research, then trends in higher education. A white paper process is under development. The strategic planning website currently shows the last strategic plan, but this will be updated to the current process and will provide an email address for feedback on the strategic plan.
 - b) Chair Harrington reminded committee chairs that the senate website is available to post documents and blogs. Chairs should submit documents or blogs for posting on their webpages to the Faculty Senate office (<u>FSenate@ucf.edu</u>).
- 5) Recognition of Guests

- 6) Report of the Provost Interim Provost Michael Johnson
 - a) Interim Provost Michael Johnson spoke about COVID, the President's 2021 Strategic Investment Program, administrator review, deans and searches, and the 2020 make-up ceremony. For the complete report, please see Attachment B and Meeting Chat Attachment C.
 - b) Questions from senators: Chair Harrington asked how faculty can find out the SIP award winners and Provost Johnson said that information will be emailed out soon. Discussion was held between the Provost and several senators regarding the President's executive order requiring vaccine mandates and the conflicting Governor's executive order and how the university will handle the situation. The Provost acknowledged that this could affect federal grants coming to the state but did not have an answer yet as the university



administration is still working on a solution. Another senator asked about whether faculty are aware that even though they are under the age of 65 that they can go and get the booster shot. Vice Provost Jana Jasinski said that Dr. Deichen had sent out a communication to the university. Chair Harrington stressed that faculty tell their colleagues. Discussion ensued between the Provost and several senators regarding international graduate students and faculty and the newly mandated screening process. The Provost said that the new process could cause a delay in hiring and that names of interviewees should be provided as soon as possible to cut down the wait time. He noted that information will need to be provided as part of application package.

 - i) COACHE Results Motion to put the COACHE results on the November 4 senate meeting agenda, second, vote taken electronically, 17 yes/0 no, motion carries. The COACHE results will be presented as the Campus Climate Report at the November 4 Senate meeting. They will have 10 minutes for the report and 10 minutes for questions.
- 9) Committee Reports
 - a) Linda Walters gave the report for Research Council. Reid Oetjen gave the report for the Ad Hoc Budget and Labor Crisis Response Committee. He asked the Steering Committee to consider disbanding the committee. Motion to disband the Ad Hoc Budget and Labor Crisis Response Committee, second, vote taken electronically via Zoom, 15 yes/0 no, motion passes. Chair Harrington thanked the committee and discharged them. Chair Harrington gave the report for the Information Technology Committee. See Attachment D for full reports.

 - a) A senator stressed that faculty should continue to be involved in pandemic issues and would like to keep the Ad Hoc Health and Safety Crisis Response Committee in session. Senator King said they plan to keep the committee going at least through the winter due to possible spikes.

Faculty Senate Steering

- Thank you, Joe, and good to be here with all of you in person.
- It's a busy time, stressful for some ... important to recognize that many good things are happening on many fronts at the university ...
- Physicist Dan Britt is part of team to analyze data from NASA's Lucy mission
 Lucy launched Saturday, has captivated people across the globe
- Our UCF Moot Court teams recently placed first *and* second in winning the University of Chicago's Invitational Tournament
 - Topped 26 other teams from Yale, the University of Chicago and the University of Toronto, among others
- The Association for Counselor Education and Supervision recently honored our counselor education program with its master's program award
 - Also, J. Richelle Joe, associate professor of counselor education, received the association's Outstanding Teaching Award
- Hispanic Outlook magazine has ranked UCF the No. 5 in the nation for conferring bachelor's degrees to Hispanics
 - About 28 percent of our student body identify as Hispanic
- Another record year in research funding, \$213 million, despite pandemic
 - Five straight years of increases
- UCF's Sudipta Seal and Griff Parks teamed with Kismet Technologies to create a long-lasting cleaning agent that protects against viruses for up to a week; we'll report on this at a BOG meeting in November

COVID

- The pandemic has not ended but we have reached a stable point
- So far managed to avoid runaway infection, and cases are relatively low
- We reached 71% students fully vaccinated, and expect to hit 75%
- Based on CDC guidelines for educators, all faculty and staff vaccinated at least six months ago are eligible for boosters. Ask to schedule through vaccine.gov.

- UCF's supply limited
- I am increasingly optimistic that this will end up a successful semester. Pandemic isn't over, but we may be heading into the stage where COVID is endemic something we learn to live with.

President's 2021 Strategic Investment Program underway

- First of the Strategic Investment Program categories finalized: 17 Jump Start projects selected among 60 applicants
 - UCF Today awards announcement story posted this afternoon
 - Lead investigators from six colleges (CAH, COM, Grad Studies, COS, Optics/Photonics, Engineering, plus Office of Research)
- Other two funds Academic Excellence and Student Success being evaluated now.
- Remainder of the strategic fund pulled from colleges and administrative areas earmarked for raises; but this depends on successful negotiations with unions

Administrator review

- Senate passed resolution last November (2020-2021-6, see bottom of these remarks) on a five-year review of faculty-facing vice presidents and vice provosts; president and I agreed, and are working on a process
- Wanted you to see the administrators who might be involved

- Dr. Maggy Tomova, dean of the College of Sciences, joined us Monday from the University of Iowa
- Beau Case from the University of Toledo is our founding dean of Libraries, starts in four weeks

- Nationwide search for CCIE starting; search committee named, firm hired, Deans Mary Lou Sole and Sheila Amin Gutiérrez de Piñeres co-chair
- Search also getting started for Associate Provost for UCF Downtown, chaired by Jana Jasinski

Resolution 2020-2021-6 Five-Year Review of Faculty-Facing Vice Presidents and Vice Provosts

Whereas, The University of Central Florida is committed to an open and transparent evaluation process for all faculty, staff, and administrators; and

Whereas, many faculty-facing vice presidents and vice provosts have not had an evaluation that included broad and meaningful input from all the stakeholders that the vice presidents and vice provosts interact with and over which they have supervision; and

Whereas, the current evaluation process does not provide adequate input from faculty and other relevant stakeholders into the initial or recurrent evaluation of many faculty-facing vice presidents and vice provosts; and

Whereas, UCF has a well-developed evaluation process for deans at five-year intervals, which includes specific steps such as the charging of an evaluation review committee led by a peer, the filling of the committee with designated categories of faculty, staff, student, and administrative members, campus communication of the evaluation, feedback of the dean's performance provided by a survey, committee review of the feedback, and delivery of a report to the provost; therefore

Be it Resolved that the offices of the president and provost develop a procedure for five-year evaluation of all faculty-facing vice presidents and vice provosts that mirrors the review committee process developed for deans; and

Be it Further Resolved that faculty and all relevant stakeholders have the ability to provide feedback concerning the strengths and weaknesses of the vice presidents or vice provosts to this review committee; and

Be it Further Resolved that the president or provost shall use the committee report as advisory in nature to make a decision to renew or discontinue appointment of the vice president or vice provost under review.

- Approved by the Faculty Senate on November 19, 2020.

- Transmitted to Interim Provost Michael Johnson on December 15, 2020.
- Approved by Interim Provost Michael Johnson on December 17, 2020 noting, "I will work with Faculty Excellence to develop processes. They will not be exactly the same as the procedure for deans, but will share the characteristic of getting input from stakeholders across the university."

October 12, 2021

Committee met for about an hour. Discussion was held on topics of Linux support and the upcoming IT strategic plan. In addition, to basic Linux support that will be organized through Chad Macuszonok and Shafaq Chaudhry in Office of Research IT, helping faculty with machine specifications (for a purchase process) will also be supported through Office of Research IT. Matt Hall (CIO) reviewed the major September 16, 2021 outage and went through issues that occurred and future plans to avoid those points of failure. Within the upcoming IT strategic plan, Matt Hall discussed issues with the wireless network that they hope to address, the committee discussed items that might be in the "common good" for UCF and UCF IT to cover. Proposed committee product for the year is a process/policy for evaluating what software is common-good and how to determine charging.

Personnel Committee with Chair Edwin Torres calling the committee to order. We discussed the Topics List forwarded to us by Steering. We deferred Faculty Grievances to the UCF Union and Out-of-Unit Faculty Benefits to the Benefits Committee. Topics continuing to be considered by the Personnel Committee are: Faculty Exit and Stary Interviews; Faculty Involvement in Hiring; Anonymous Supervisor Surveys; Faculty Administrative Action; Award Structure for TIP, RIA, SOTL, etc.; Faculty Salary Compression.

Request to Speak at Senate/Steering

October 18, 2021 – Policy Committee

Policy Committee: This committee has met twice with UCF Global/OR to share suggestions and concerns about the draft Faculty International Travel policy. UCF Global was very responsive



after the first meeting and made significant changes to the document based on faculty input. The revised document was shared with all faculty members through Faculty Senate and there were a significant number of faculty responses via email. Other interested faculty joined the zoom meeting on Monday, October 18. The second meeting was attended by Global/OR. Faculty shared additional questions/concerns about the revised draft policy. By November 1, the draft policy will go to the UCF Policy and Procedures Committee. Once posted by them, faculty will have an additional 2 weeks to comment on draft policy.

October 11, 2021 - Compliance Committee

Committee is working on 2 agenda items. First is looking at EHS concerns and experiences since EHS moved out of OR in 2019. Second is determining how best to get a Research Misconduct Review Committee in place to expedite response time.

October 11, 2021 - Internal Research Committee

Committee focused on 2 issues. First was understanding how UCF does and should deal with technology and equipment not managed by facilities. Who is responsible for maintenance and upkeep? Second, Dr. Klonoff asked the group to formulate a transparent workflow process for when a faculty member asks OR to purchase software.

As we are still awaiting the complete implementation of Kuali, there were no courses available for approval at that time. During the meeting, Drs. Theodora Berry and Wayne Bowen gave a brief discussion on the General Undergraduate Requirement Committee (GURC) and its role in the approval of General Education Program (GEP) courses. Unlike Digarc, Kuali can recognize all designated GEP courses. As GURC has now been built into the workflow, they will receive GEP courses before the UCRC. In addition, Dr. Tim Letzring gave a Kuali update. Danielle Hutson, the UCRC Coordinator, walked the committee through Kuali, discussing the role of individual members in the course review process with the new operating system.
