

Report of the Provost

Thursday, November 4, 2021, 3 p.m. to 5 p.m., Zoom

- Tomorrow is a big day! Spirit Splash is back, and so are approximately 1,700 graduates from 2020 for a make-up ceremony starting at 9 a.m. at Addition Financial Arena ...
 - Commencement speaker is three-time UCF grad Darin Edwards, who developed Moderna's COVID-19 vaccine
- It's a busy time, stressful for some ... the pandemic is still with us ... important to recognize that many good things are happening on many fronts to advance the university ...
- On Friday, UCF earned the Seal of Excelencia as a top institution for Latino Students from Excelencia in Education in Washington, D.C.
 - UCF is one of just 10 institutions nationwide to earn the Seal of Excelencia this year, and one of just 24 institutions overall to have earned the certification.
- Seal is earned by:
 - demonstrating evidence of effective and intentional institutional practices that serve Latino students;
 - positive momentum for Latino students' progress;
 - o and a dedication to transform the institution into an environment where Latino students can thrive.
- *Hispanic Outlook* magazine has ranked UCF the No. 5 in the nation for conferring bachelor's degrees to Hispanics
 - About 28 percent of our student body identify as Hispanic
- Physicist Dan Britt is part of team to analyze data from NASA's Lucy mission
 - Lucy launched on October 16 on a 12-year mission to study the Trojan asteroids, which share Jupiter's orbit around the sun; mission has captivated people across the globe
- Our UCF Moot Court teams recently placed first *and* second in winning the University of Chicago's Invitational Tournament
 - Topped 26 other teams from Yale, the University of Chicago and the University of Toronto, among others
- The Association for Counselor Education and Supervision recently honored our counselor education program with its master's program award

- Also, J. Richelle Joe, associate professor of counselor education, received the association's Outstanding Teaching Award
- Another record year in research funding, \$213 million, despite pandemic
 - Five straight years of increases
- UCF's Sudipta Seal and Griff Parks teamed with Kismet Technologies to create a long-lasting cleaning agent that protects against viruses for up to a week; we'll report on this at a BOG meeting later this month

COVID

- The pandemic has not ended but we have reached a stable point
- So far managed to avoid runaway infection, and cases are relatively low
 - As of Monday (Nov. 1), we reached nearly 73% (72.8%) of students fully vaccinated, and expect to hit 76% (one shot rate is 76.1%)
- Based on CDC guidelines for educators, all faculty and staff vaccinated at least six months ago are eligible for boosters. Ask to schedule through vaccine.gov.
- UCF's supply limited
- Pandemic isn't over, but we may be heading into the stage where COVID is endemic something we learn to live with.

President's 2021 Strategic Investment Program underway

- First of the Strategic Investment Program categories finalized: 17 Jump Start projects selected among 60 applicants
 - UCF Today posted a story on the awardees
 - Lead investigators from six colleges (CAH, COM, Grad Studies, COS, Optics/Photonics, Engineering, plus Office of Research)
- Other two funds Academic Excellence and Student Success being evaluated now.
- Remainder of the strategic fund pulled from colleges and administrative areas
 earmarked for raises; but this depends on successful negotiations with unions

- Dr. Maggy Tomova, dean of the College of Sciences, joined us October 18 from the University of Iowa
- Beau Case from the University of Toledo is our founding dean of Libraries, starts a week from tomorrow (Friday, November 12)
- Nationwide search for CCIE starting; search committee named, firm hired, Deans Mary Lou Sole and Sheila Amin Gutiérrez de Piñeres co-chair
- National search underway for FCTL director

November 3, 2021

Committee did not reach quorum, however, committee agreed not to adjourn and to discuss but not vote on agenda items. The committee discussed the need to request a presentation related to how budgets will be managed with the Workday ERP upgrade. Committee revisited the topic of library funding but agreed that discussion should be tabled pending input from the need Dean of Libraries. Committee discussed the topic of reserving on/near campus accommodations for mid-term visiting scholars on J1 visas. It was noted that the process of bringing J1 scholars varies between colleges, and more information was needed on potential issues facing J1 scholar accommodations. Committee discussed sending this topic back to steering for clarifications, but a vote was not held.

Information Technology Committee

Committee met for about an hour. Discussion primarily focused on a presentation by Mike Sink from UCF IT regarding Knight Vision and the effects Workday will bring to faculty. Initially, the financial and other parts of UCF business will go online in 2022. Student modules will move at a later date, meaning PeopleSoft will continue to be used in the short term. Questions about the myUCF portal, security, and uptime were asked. Mike Sink also provided a brief demo of the mobile interface of Workday. Suggestion was made for UCF IT to provide "sneak peeks" so faculty can see what is coming. The meeting closed with agreement to start work on a process/policy product for evaluating what software is in the common good and how to determine charging.

Policy Committee: This committee has met twice with UCF Global/OR to share suggestions and concerns about the draft Faculty International Travel policy

(https://facultysenate.ucf.edu/document/2-903-3-international-travel-policy-draft/). UCF Global was very responsive after the first meeting and made significant changes to the document based on faculty input. The revised document was shared with all faculty members through Faculty Senate and there were a significant number of faculty responses via email. Other interested faculty joined the zoom meeting on Monday, October 18 (https://ucf.zoom.us/j/98557042574). The second meeting was attended by Global/OR. Faculty shared additional questions/concerns about the revised draft policy. Soon, the draft policy will go to the UCF Policy and Procedures Committee. Once posted by them, faculty will have an additional 2 weeks to comment on draft policy. The Policy Committee has now moved on to their second review of the OR DRAFT Research Misconduct Policy. This committee has met once to discuss the draft and a second meeting will be held this coming Monday (November 8) at 4 PM via zoom. All faculty are invited to read the draft policy and attend the meeting to share comments.

October 11 & 25, 2021

Compliance Committee: Committee is looking at EHS concerns and experiences since EHS moved out of OR in 2019. The committee is developing a survey that will be distributed to all Associate Deans for Research (ADRs) to understand positives and negatives of this move. Survey will be distributed on November 7 and announced at the ADR meeting on November 9. If any faculty have concerns with EHS, please share with your college ADR or directly with Shawn Burke on the Compliance Committee.

October 11, 2021

Internal Research Committee: Committee is focused on 2 issues. First is understanding how UCF does and should deal with technology and equipment not managed by facilities. Who is responsible for maintenance and upkeep? Second, Dr. Klonoff asked the group to formulate a transparent workflow process for when a faculty member asks OR to purchase software.

Vaccinations: Student health is continuing to vaccinate between 150-200 people per week. Booster shots: CDC has extended guidelines for eligibility, and many classes of people (Including teachers and staff at UCF) are now able to get these boosters.

Conditions on campus: Current guidance on masks and gatherings were discussed, with questions regarding whether some restrictions will remain (mask guidance) whereas others may be decreased (limits on gatherings).



Flu vaccinations: SGA has been encouraging this for students with cross-Florida competitions. Continued messaging for flu vaccines will help the COVID situation as well.

Messaging about COVID: There was discussion of having the administration send a ~monthly update on COVID condition even if no significant changes have occurred. This would ensure that all stakeholders felt they had up to date and accurate information, and can expect it into the future in case of a winter COVID spike. The recent email about booster availability was the first COVID specific messaging in about 2 months, which was considered too infrequent.

3 4 5 6	In reference to the recent denial by the University of Florida of several faculty members' requests to testify as paid expert witnesses in court, the University of Central Florida Faculty Senate supports the following resolution of the Florida Board of Governors' Advisory Council of Faculty Senates:
7 8 9 10 11	The State University System of Florida Advisory Council of Faculty Senates, representing the faculty of all twelve public universities in Florida, have united to express our grave concerns over the recent events taking place at our member institution, the University of Florida. Together, we express deep alarm about what appears to be a serious breach of academic freedom.
12 13 14 15 16 17 18 19 20 21	In its 1940 Statement of Principles on Academic Freedom and Tenure, based on its original 1915 Declaration of Principles, the American Association of University Professors set forth clear professional norms regarding faculty participation in civic discourse: "College and university teachers are citizens, members of a learned profession, and officers of an educational institution. When they speak or write as citizens, they should be free from institutional censorship or discipline" Recognizing their obligations as representatives of their disciplines and universities, the AAUP further notes that faculty have an obligation in such circumstances to speak with accuracy and respect for others, and as individuals rather than institutional speakers. This is precisely what the faculty at the University of Florida were attempting when their public participation was blocked by the university.
22 23 24 25 26 27	When faculty are invited to participate in policy processes through their speech or research, they do so as objective experts, prepared by academic training to focus on evidence over bias. When they are denied the right to participate, not only does it undermine both freedom of inquiry and the independence of the university, it denies the citizens of the State, to whom the university is ultimately responsible, access to the most current and independent knowledge available on the issue under consideration.
28 29 30 31 32 33	In these recently publicized instances, faculty in a variety of disciplines attempted to engage in professional activity consistent with the principles of academic freedom that have been protected in the United States for over 100 years. As fellow faculty and stewards of the academy, we rise to defend these principles, especially when they are challenged in what appears to be a systematic way. We urge the University of Florida to reconsider these decisions, and we urge the State University System to reaffirm its commitment to academic freedom and freedom of speech as core values of all public institutions of higher learning.
