Thesis Chair

The HIM thesis chair must be a UCF tenured or tenure-earning faculty member and a subject matter expert in the major of which the student is applying for the Honors in the Major program. *Exceptions may apply to students from departments or colleges with grandfathered agreements (i.e., Legal Studies, Nursing, and Regional Campuses).

Thesis Committee members

The Honors in the major program requires that at least one additional person serve on the thesis committee. The additional member can be selected from within or outside of the major. The committee member must hold a terminal degree and/or be a subject matter expert in the field of the student's HIM thesis. *Exceptions may apply upon the recommendation of the Department Chair to the Dean of TBHC. The Department Chair would be required to provide a justification statement explaining why the proposed committee member should be considered to serve on the thesis committee. The

recommendation and justification statement along with a copy of the proposed committee member's CV should be submitted to the Dean of TBHC for final review and approval.
