5) New Business.

a. Excellence in Research Rubric. The first item was review of the draft rubric for the Excellence in Research Award that is decided by Research Council members each year.

The Council reviewed the revised rubric prepared by the Council's committee for the 2024 Excellence in Research Award, suggesting the following amended rubric be used next year. Additional commentary was provided by the Council, with several comments concerned about the "Excellent" and "International" rubric category. One important suggestion was to swap the column names from Excellent, Very Good, Good, and Emerging to International, National, Regional and Local. Then within the boxes, the judges would report each as Excellent, Very Good, Good or Emerging. This removes "International" as being the top criteria for folks whose research is focused at a national or regional level.

It appeared that the Council collectively noted consensus with the committee's revision that combined publications, presentations and external support into one rubric category. Adjustments were intended to remove some of the inadvertent bias in the previous rubric toward participants from STEM and heavily grant-funded disciplines. The evaluations should be based on applicant accomplishments within the past 3 years. Applicants and their colleges should provide evidence about average productivity norms in their discipline areas, possibly using Academic Analytics. This rubric should come back to the Council (probably via email) for another review of the newest committee improvements.
